

Your memorandum ref.: 2453/conf/1148/JDB dated 2nd October 2005, submitting for consideration CV's of prospective Site Supervisory Staff refers.

We comment as follows:

- 1) Senior Resident Engineer Mr. Essam El-Din Atef El Sherif.
 - a) In accordance with current procedures, Drainage Affairs Projects Division Personnel Sub-Committee (PDPSC) has reviewed the CV and interviewed the proposed candidate.
 - b) Consequent to the interview, the PDPSC is satisfied that Mr. Essam El-Din Atef El Sherif has demonstrated an ability to undertake the role of Senior Resident Engineer for this project on the understanding that:
 - i) Satisfactory reports of Mr. Sherif performance over a two month probationary period from the date of the commencement of his duties are received.
 - ii) He shall solely be engaged on this project and gives the whole of his time to superintendence of the same.
 - c) Please make immediate arrangements in respect of Mr. Essam El-Din Atef El Sherif mobilisation
- 2) Assistant Resident Engineer Mr. Mohammed Abdel Fattah Abou El Ela.

 - b) Whilst the submitted CV suggests a record of some experience with drainage related projects, the PDPSC regrets that consequent to the interview with the candidate, it cannot recommend approval of Mr. Mohammed Abdel Fattah Abou El Ela for the position of Assistant Resident Engineer (Civil).
 - c) Accordingly, please submit details of an alternative suitably qualified candidate with demonstrable experience in all aspects of site supervision of large sewerage related projects.

3) Site Inspector - Mr. TM Abraham.

- a) In accordance with current procedures, Drainage Department Projects Division Personnel Sub-Committee (PDPSC) has reviewed the CV of the proposed candidate.

- a) The PDPSC has no objection in principle to Mr. Raj P Varghese being engaged as Secretary in this project on the understanding that:
 - i) Satisfactory reports of Mr. Varghese performance over a one month probationary period from the date of the commencement of his duties are received.
 - ii) He shall solely be engaged on this project and gives the whole of his time to superintendence of the same.
